**Red Cards** - All people in the United States, regardless of immigration status, have certain rights and protections under the U.S. Constitution. **Step-by-Step Family Preparedness Plan -** Every family should have a Family Preparedness Plan in case of an emergency. It is critical for immigrant families to think ahead and set more concrete plans for immigration emergencies that can arise.
